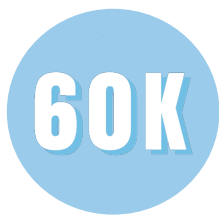
The group's cross-functional approach is based on a purposely global presence and on a network of reliable foreign correspondents, each specialized in their domain.
